

**THIS INDENTURE** MADE THE *29<sup>th</sup>* day of *Sept.*

in the year of our Lord 1825 Between *Sam Cooley* Overseer of the Poor of the District in the County of Rockingham of the one part and *Jacob Carbaugh* of the other part, witnesseth, that the said Overseer of the Poor aforesaid by virtue of an Order of the Court of the County aforesaid baring date the *June* day of *1825* in the year has placed and bound and by these presents doth place and bind *James Adams* of the age of *fifteen years in July last* to be an Apprentice with him the said *Jacob Carbaugh* and as an Apprentice with him the said *Jacob Carbaugh* to dwell from the date of these presents, until the said *James Adams* shall arrive and come to the age of *Twenty one* years, according to the Act of the General Assembly in that case made and provided, by and during all which time and term the said *James Adams* shall the said *Jacob Carbaugh* his said *Master* well and faithfully serve in all such lawful Business as the said *James Adams* shall be put unto by *his said Master* according to the Power, Wit and Ability of *him* the said *James Adams* honestly and obediently in all things behave towards *the* said *Jacob Carbaugh* and honestly and orderly towards the rest of the Family of the said *Jacob Carbaugh* And the said *Jacob Carbaugh* for himself *his* Executors and Administrators doth hereby promise and covenant to and with the said Overseer of the Poor and his Successor for the time being, that the said Apprentice shall in the Craft, Mystery and Occupation of a *Farmer* which he the said *Jacob Carbaugh* now useth, after the best manner that he can or may teach, instruct and inform or cause to be taught, instructed and informed, as much as thereunto belongeth or in any wise appertaineth, and that he the said *Jacob Carbaugh* shall also find and allow unto the said Apprentice sufficient meat, drink, apparell, washing, lodging, and all other things needful or meet for an Apprentice during the term aforesaid: And also that the said *Jacob Carbaugh* shall teach or cause to be taught to the said *James Adams* Reading, Writing, and Common Arithmetic including the Single Rule of Three, and will moreover pay to the said *James Adams* the Sum of *Twenty* Dollars at the Expiration of the aforesaid Term.
