

THIS INDENTURE MADE THE *fifth* day of *January*

in the year of our Lord 18 *21* Between *Aaron Solomon* Overseer of the Poor of the *South East* District in the County of Rockingham of the one part and *John Brillhart*

of the other part, witnesseth, that the said Overseer of the Poor aforesaid by virtue of an Order of the Court of the County aforesaid baring date the *day of December* in the year of *1820*

has placed and bound and by these presents doth place and bind *Nancy Cooper* of the age *nine years nine months five days* ~~years~~, to be an Apprentice with him the said *John Brillhart*

and as an Apprentice with him the said *John Brillhart* to dwell ~~from the date of these presents,~~ until the said *Nancy Cooper* shall arrive and come to the age of *eighteen*

years, according to the Act of the General Assembly in that case made and provided, by and during all which time and term the said *Nancy Cooper* shall the said *John Brillhart* her ~~the~~ said *Master*

well and faithfully servè in all such lawful Business as the said *Nancy Cooper* shall be put unto by her said *Master* according to the Power, Wit and Ability of *the said Nancy Cooper*

and the said *Nancy Cooper* shall *her* said *Master* honestly and obediently in all things behave towards and honestly and orderly towards the rest of the Family

of the said *John Brillhart* And the said *John Brillhart* for himself *his* Executors and Administrators doth hereby promise and covenant to and with the said Overseer of the Poor and his

Successor for the time being, that the said Apprentice shall in the Craft, Mystery and Occupation of ~~Housewifery~~ *Sewing & C. Spinning Knitting* ~~which he the said~~ *Sewing & C.* ~~now teach,~~ after the best manner that he can or may teach,

instruct and inform or cause to be taught, instructed and informed, as much as thereunto belongeth or in any wise appertaineth, and that he the said *John Brillhart* shall also find and allow unto the said Apprentice sufficient

meat, drink, apparel, washing, lodging, and all other things needful or meet for an Apprentice during the term aforesaid: And also that the said *John Brillhart* shall teach or cause to be taught to the said *Nancy Cooper*

Reading, Writing, ~~and Common Arithmetick including the Single Rule of Three~~ and will moreover pay to the said *Nancy Cooper* the Sum of *fifteen* Dollars at the Expiration of the

aforesaid Term. IN WITNESS whereof the Parties to these Presents have interchangably set their Hands and Seals the Day and Year above written.
