Successor for the time being, that the said Apprentice shall in the Craft, Mystery and Occupation of a

which he the said _____ now useth, after the best manner that he can or may teach,

instruct and inform or cause to be taught, instructed and informed, as much as thereunto belongeth or in any wise appertaineth, and that

he the said *James McBush* shall also find and allow unto the said Apprentice sufficient

meat, drink, apparel, washing, lodging, and all other things needful or meet for an Apprentice during the term aforesaid: And also that

the said *James McBush* shall teach or cause to be taught to the said *Angelina Harrison*

Reading, Writing, and Common Arithmetic including the Single Rule of Three, and will moreover pay to the said *Angelina*

Harrison the Sum of *Twenty* Dollars at the Expiration of the
