

THIS INDENTURE MADE THE *Ninth* day of *August*

in the year of our Lord 18*22* Between *Henry Sipe* Overseer of the Poor of the *South East* District in the County of Rockingham of the one part and *Charles Veyvor*

of the other part, witnesseth, that the said Overseer of the Poor aforesaid by virtue of an Order of the Court of the County aforesaid baring date the *Third* day of *June* in the year *Eighteen Hundred and twenty one* has placed and bound and by these presents doth place and bind *Susannah Blumb* of the age of *seven years* years, to be an Apprentice with him the said *Charles Veyvor* and as an Apprentice with him the said *Charles Veyvor* to dwell from the date of these presents, until the said *Susannah Blumb* shall arrive and come to the age of *Eighteen* years, according to the Act of the General Assembly in that case made and provided, by and during all which time and term the said

Susannah Blumb shall the said *Charles Veyvor* his said *Master* well and faithfully serve in all such lawful Business as the said *Susannah Blumb*

shall be put unto by *Charles Veyvor* according to the Power, Wit and Ability of *Susannah Blumb* the said *Susannah Blumb* honestly and obediently in all things behave towards *Charles Veyvor* said *Susannah Blumb* and honestly and orderly towards the rest of the Family of the said *Charles Veyvor* And the said *Charles Veyvor*

for himself *his* Executors and Administrators doth hereby promise and covenant to and with the said Overseer of the Poor and his Successor for the time being, that the said Apprentice shall in the Craft, Mystery and Occupation of a *lock Smith some and sponsor* which he the said *Charles Veyvor* now useth, after the best manner that he can or may teach, instruct and inform or cause to be taught, instructed and informed, as much as thereunto belongeth or in any wise appertaineth, and that he the said *Charles Veyvor* shall also find and allow unto the said Apprentice sufficient meat, drink, apparell, washing, lodging, and all other things needful or meet for an Apprentice during the term aforesaid: And also that

the said *Charles Veyvor* shall teach or cause to be taught to the said *Susannah Blumb* ~~the Bible well Reading, Writing, and Common Arithmetic including the Single Rule of Three,~~ and will moreover pay to the said *Susannah Blumb* the Sum of *Twenty* Dollars at the Expiration of the aforesaid Term.
