Re. recordation order

Gentlemon:

You have just entered what may properly be called "the recordation order" in the Park Concemption proceedings pending in your respective counties.

May we offer a few suggestions for your consideration and approval as to the form of compliance with that order.

At the cost of no little effort and thought we have succeeded in maintaining a notable degree of uniformity in the course of the proceedings in the eight counties in the park area; and for many reasons, which will readily suggest themselves, it appears to be highly desirable that as far as practicable, a like degree of uniformity should be maintained in the recordation, in your respective deed books, of the orders, judgments and so much of the proceedings as "will show the condemnations had, and include a description of the lands and of the estate or interest therein condemned" and acquired by the State Cormission on Conservation and Development.

You have all been good enough to accede to our request that a special deed book be set uside for these records.

We attach herewith a rough memo., covering a uniform procedure in recording the orders, judgments, se, which, subject to your approval, might be followed in each county.

The writer takes this opportunity to express his thanks to each one of you for the many courtesies shown him throughout the course of these proceedings in your respective offices.
