We should greatly appreciate your advising us in any case wherein the owners on the attached list have moved the court for orders on the Treasurer for their distributive share of the award, without at the same time including our claim for payment; as in all such cases it is our purpose to pray the court for permission to be heard on our claims before the entry of any order of distribution in that particular case. Up to this time we ourselves have not moved for orders of payment of our claims because we did not wish to embarrass the owners or to burden them with the necessity for awaiting our attendance at the hearing on their claims in any case in which they themselves raised no objections to our claims. But where objection has been made or where there is reason to anticipate such objection it is our purpose to pray the court for an opportunity to be heard before the entry of orders of distribution of any part of the funds in such cases.
