I claim a right, title, estate or interest in a tract or parcel of land within the area sought to be condemned, containing about 10 A + 1 acres, on which there are the following buildings and improvements:

This land is located about 3 miles from Rebston Virginia, in the Stoneval Magisterial District of said County.
