

**THIS INDENTURE** MADE THE *Twentyeth* day of *August*

in the year of our Lord 1826 Between *William Chirreyholms* Overseer of the Poor of the District in the County of Rockingham of the one part and *John Regleman of said County*

of the other part, witnesseth, that the said Overseer of the Poor aforesaid by virtue of an Order of the Court of the County aforesaid baring date the *sixeth* day of *march* in the year *one Thous and Eight Hundred & 26*

*of sixteen years in*  
*January last*

has placed and bound and by these presents doth place and bind *Venus Pupp* *about 13 years* of the age *of 13*

and as an Apprentice with him the said *John Regleman* to dwell from the date of these presents, until the said *Venus Pupp* shall arrive and come to the age of *Twenty one*

years, according to the Act of the General Assembly in that case made and provided. by and during all which time and term the said *Venus Pupp* shall the said *John Regleman* his said

*Master* well and faithfully serve in all such lawful Business as the said *Venus Pupp* shall be put unto by *by his said master* according to the Power, Wit and Ability of *him the said Venus Pupp*

~~and~~ *John Regleman* and honestly and obediently in all things behave towards *his said master*

and honestly and orderly towards the rest of the Family of the said *John Regleman* And the said *John Regleman* for himself *his* Executors and Administrators doth hereby promise and covenant to and with the said Overseer of the Poor and his

Successor for the time being, that the said Apprentice shall inthe Craft, Mystery and Occupation of a *Shaemaker* which he the said *John Regleman* now useth, after the best manner that he can or may teach,

instruct and inform or cause to be taught, instructed and informed, as much as thereunto belongeth or in any wise appertaineth, and that he the said *John Regleman* shall also find and allow unto the said Apprentice sufficient

meat, drink, appearel, washing, lodging, and all other things needful or meet for an Apprentice during the term aforesaid: And also that the said *John Regleman* shall teach or cause to be taught to the said *Venus Pupp*

Reading, Writing, and Common Arithmetic including the Single Rule of Three, and will moreover pay to the said *Venus Pupp* the Sum of *Twenty* Dollars at the Expiration of the

aforesaid Term. IN WITNESS whereof the Parties to these Presents have interchangably set their Hands and Seals the Day and Year above written.
