Ordered that the stewart of the poorhouse (John Ludy) be allowed five hundred dollars per year payable in quarterly instalments for his services as stewart

Ordered that John Ludy pay the sum of seventy five dollars per year payable in quarterly instalments for rent of the farm attached to the poorhouse

Ordered that Shem L Heatwole W Sellers and [illegible] be appointed a committee to examine the condition of the poorhouse and settle with the stewart at the end of each quarter

On motion the board adjourned to meet on Sunday before the 3rd Monday in June 1866

At a meeting of the board of overseers of the poor for the county of Rockingham held April 16th 1866 in Harrisonburg pursuant to notice given by the President present Jacob Byerly Pres. William Sellers, Shem L Heatwole, M J Zirkle, Amos Scott

A communication of date March 26th 1866 from Maj. J S Hull superintendent of Freedman Bureau to Jacob Byerly Pres. Board of overseers of poor for Rockingham asking information as to the course of conduct adopted by the overseers in relation to destitute freeman was read and upon motion it was ordered that the president be requested to reply to the communication and inform Maj. J S Hull that such protection will be afforded destitute freedmen having a legal

residence within the county as is provided for white paupers and in all respects the overseers will be governed by the laws of Virginia in relation to that subject

On motion it was ordered that the unsettled accounts of Jacob Rohr Sr. late President of the board with the overseers of the poor be referred to Jacob Byerly president of the board for settlement

On motion the meeting adjourned

The board proceeded to the election of a physician to attend the paupers at the poorhouse wereupon Mr. Gordon and Williams were duly elected and their sallery fixed at tone hundred dollars to be paid out of the levy for the next ensuing year

Chas A Yancey now elected clerk and agent for the next year and his sallery fixed at one hundred and fifty dollars to be paid out of the levy for the next ensuing year

John Ludy was appointed stewart for the poorhouse and allowed six hundred together with the use of the farm for his services to be paid out of the levy for the next ensuing year in quarterly instalments

On motion of Henry S Wartman it is ordered that a committee of three be appointed to select a satiable farm for the use of the parish and report the term upon which it can be purchased at the next annual meeting of the board whereupon the following committee were appointed for the purpose above mentioned Henry S Wartman, Shem S Heatwole, and William Sellers on motion the president of the board was added to the committee

Ordered that the clerk of this board certify to the overseers of the poor of Albemarle County that they have paid \$45 for the support of James Gasisen a pauper from Albemarle county

Ordered that the clerk of this board certify to the overseers of Shenandoah county that they have paid \$9.00 for removing John Corbin a pauper from Shenandoah to that county

Ordered that John Ludy be allowed \$75 for entertaining the board and the same be added to his account this day allowed

On motion it is ordered that the annexed seal be adopted as the common deal of the overseers of the poor for the county of Rockingham [See original document]

On motion the board adjourned to meet again on the 18th day of August next

At a meeting of the overseers of the poor for Rockingham County held at the poorhouse of said county on Saturday the 18th day of August 1866 pursuant to adjournment

S R Allenbaugh sheriff of Rockingham Y C Ammon, Christopher Miller, John Logan, Robert Coakley and Henry Neff his deputies returned to the board list of delinquents and insolvents in the parish levy for the year 1865 which were severally examined by the board and allowed they been sworn to as the law directs

Ordered that the clerk of the board report to the next county court the amount which will be chargeable for the ensuing year on account of the parish as ascertained from allowances made at the meeting of June 12th 1866 including whatever additional allowance may be made at the present meeting

The committee appointed at the last meeting of the board consisting of H S Wartman, Shem Heatwole, Wm Sellers and Jacob Byerly to select a suitable farm for the use of the parish and report the terms upon which it can be purchased at this meeting through their chairman H s Wartman made report in writing setting forth that they had has offered them a number of farms and that they considered a proportion submitted by Jonas A Lowenbach as the best he having offered his farm situated on Grassey Creek at \$175.00 upon the following terms \$30.00 cash or when permission is given and the residue in four equal annual payments of \$41.25 each payable on the 1st day of September 1867-8-9-70 he further agreeing to purchase the present poorhouse farm for the sum of \$30.00 or to take it for the down payment on his farm

After sum discussion the report was received

On motion it is ordered that Chas A Yancey agent be directed to ask the current of the county court to purchase the farm offered by Mr. Lowenbach and to sell the present poorhouse farm to him upon the conditions reported by the committee and in the event of such amount being obtained the President and clerk are hereby directed and empowered in the name and under the seal of the overseers of the poor for the county of Rockingham to do whatever may be necessary to complete the agreement between said Lowenbach and and saif overseers

Ordered that as it appears to the board that John T Harris late agent clerk and attorney could have drawn his allowance for the year ending June 1864 and did not do so it is ordered that the allowance made him at the meeting held June 12 1866 of \$300 be reduced to \$150

At a meeting of the overseers of the poor for the county of Rockingham held at Harrisonburg on the 8th day of Sept 1866 Present Jacob Byerly President, Wm Sellers, H S Wartman, Abrm Brannerman, M J Zirkle

On motion it is ordered that whereas consent has been obtained from the county court of Rockingham allowing the overseers of the poor to complete the agreement entered into between them and Jonas A Lowenbach tendering the purchase of his farm on grassy creek and for the conveyance to him in part payment therefor of the poorhouse farm therefore for the purchase of improving the same and erecting such buildings as may be necessary for the accommodation of paupers the president of the board is hereby directed to appoint a committee consisting of three overseers whose duty it shall be to decide upon what may be necessary for the above purpose the plan specifications and have the same built as may seem to them most advantageous for the parish that said committee be and are hereby empowered to make contract and do whatever else may be necessary to carry out the purpose above and that they be required to make a report thereof to the next annual meeting to be held in June next

The president appointed under the foregoing order for the purpose therein specifics the following overseers to wit

Henry S Wartman W Sellers Shem S Heatwole

On Motion it was ordered that the Pres. Jacob Byerly be added to the above committee

On motion it is ordered that the sheriff be directed to pay over to each overseer out of the monies remaining in his hands from the levy made in 1865 unappropriated the sum of fifty dollars

On motion it is ordered that the overseers who shall receive the above amount of \$50 appropriate the same as so much thereof as may be necessary to the purchase of necessities for the paupers of their districts and render an account of the name to the next meeting of the board

On motion it is ordered that the board do now adjourn to meet again on Sunday before the third Monday in June 1867

The following allowances received fifty dollars from the sheriff as authorized by the meeting held in Harrisonburg on the 18th day in August 1867 to wit S Heatwole, W Sellers, H S Wartman, Abrm Brannerman and report that said amount had been expended in purchasing supplies for the use of paupers in their respective districts and it is ordered that the sheriff be credited by said amounts

Overseers H S Wartman, M J Zirkle, and W Sellers were appointed a committee whose duty it shall be to visit and superintend the poorhouse and also to examine and settle the account of the stewart at the end of each quarter

Ordered that John Ludy be allowed the same wages as stated at the last meeting until the new poorhouse is completed and the paupers moved

Dr. Gordon and Williams were selected physicians to the poorhouse for the next ensuing year and their salary fixed at \$100

Sheriff S R Allenbaugh and his deputies Henry Neff, R G Coakley, C Miller, W H Rodeffer, and C Ammon made reports of the number of delinquents returned which are to be received they having been sworn to as the law directs

Ordered that the clerk of the board certify to the parish of Augusta that this board has apparated the sum of twenty one dollars and sixty eight cents for the support of Hardwick (blind man) a pauper from said county who had moved to this county within the last twelve months and ask that the said amount may be refunded

Ordered that the agent of the board be and he is hereby directed out of funds in his hands or which may hereafter come into his hands not otherwise appropriated to pay all orders or drafts drawn on him by the committee heretofore application for the purpose of building a new poorhouse and known as the building committee of which H S Wartman is chairman

Chas A Yancey was unanimously reelected clerk of the board and agent of the overseers and allowed for his services as such a salary of one hundred and fifty dollars to be paid out of the levy for 1868 and 1869

Ordered that the agent execute bond wills security as required by law for 10,000 condition for the faithful performance of his duties

Ordered that the agent Chas A Yancey collect from from the overseers of the poor of Augusta county the sum of nine dollars levied by this board for the benefit of Mrs Fuller and her three children paupers from said county of Augusta

The agent present an account from the overseers of Shenandoah County against the overseers of Rockingham for a levie made for the benefit of Elizabeth Bright and Fanney Bright paupers from this county amounting to forty dollars which is ordered to be paid out of money to come into his hands from the levy of 1868 therefrom nine dollars amt due Jackson Krupp for removing John

Corbin family paupers from said county back to Shenandoah in 1866 which amt has been certified by the clerk to the said county and has not been paid.

The agent is directed out of monies in his hands or to come into his hands hereafter to pay Jackson Krupp nine dollars for removing John Corbins family to Shenandoah

The board met pursuant to adjournment present Jacob Byerly Pres Overseer Amos Scott, Shem Heatwole, H T Wartman, W Sellers, M J Zirkle and Abrm Bannerman

On motion of H T Wartman it was ordered that the board select a manager of the poorhouse farm and stewart of the poorhouse whose duty it shall be to provide for the pauper sent to the poorhouse suitable diet and clothing and other things necessary for their comfort and conduct the farming operations of the farm who shall have entire controle of the farm and property therein belonging to the parish and out of the products arising therefrom he shall first provide for all paupers under his controle when in his judgement the interest of the parish requires it he shall be empowered to purchase such articles or stocks may be necessary to the proper cultivation of the farm and may also sell such things as may not be necessary for the support of paupers. He shall have power to purchase all necessary clothing for paupers and other things not produced by him on the farm. He shall annually at the regular meetings of the board render an account of the receipts and disbursements made by him during the proceeding year. He shall hold his office for one year and receive for his compensation such salary as may be agreed upon by the board for the faithful discharge of his duties he shall to the overseers a bond with security in the penal sum of five thousand dollars

Ordered that until otherwise ordered the stewart and manager be allowed a salary of seven hundred dollars payable semiannually and in addition thereto he be allowed house rent free of charge pasture and forage for two cows and one horse pasture for six hogs five wood and fruit from the farm for the use if his family and the present gardin attached to the poorhouse

The position of stewart and manager was tendered E Mason who came in and in the presence of the board accepted the position under the forgoing provisions

The pres on behalf of the overseers was directed to enter into and article of agreement with Mr Mason and take bond from him in pursuance of the forgoing agreement

On motion of H T Wartman a member of the building committee it was ordered that the thanks of the overseers of the poor be tendered J A Lowenbach for his kindness in furnishing the

building committee with means whereby they were enable to prosecute the work of building the new poorhouse

Ordered that the clerk furnish Mr. Lowenbach with a copy of the forgoing order

On motion it was ordered that W Sellers be requested to appoint the stewart in purchasing as many horses and gear as may be necessary to carry on the farming operations of the poorhouse farm
