I claim a right, title, estate or interest in a tract or parcel of land within the area sought to be condemned, containing about 10 1/2 acres, on which there are the following buildings and improvements: No improvements on this land

This land is located about 3 miles from Elkton Virginia, in the Stonewall Magisterial District of said County.
