*Levi Reedy* \_\_\_\_\_ of the other part witnesseth, that the said Overseers of the Poor by virtue of  
an Order of the County aforesaid bearing date the \_\_\_\_\_ day of *April* in the year 1844 has  
placed and bound and by these presents doth place and bind *Reubin Moore* of the age of *thirteen*  
~~year~~ <sup>on the 11<sup>th</sup> day of June 1844</sup> to be an Apprentice with him the said *Levi Reedy* and as an Apprentice  
with him the said *Levi Reedy* to dwell from the date of these presents, until the said  
*Reubin Moore* shall arrive, and come to the age of *Twenty one* years, according  
to the Act of the General Assembly in that case made and provided. For and during all which time and term the said  
*Reubin Moore* shall the said *Levi Reedy* well and faithfully serve in all such lawful Business as the said *Levi Reedy*  
by his said *Master* according to the Power, Wit and Ability of the said *Reubin Moore* and  
the said *Reubin Moore* honestly and obediently in all things behave towards the said *Levi*  
*Reedy* and honestly and orderly towards the rest of the Family of him the said *Reedy*  
And the said *Levi Reedy* for himself his Executors and Administrators doth hereby  
promise and covenant to and with the said Overseer of the Poor and his Successor in office for the time being, that the said  
Apprentice shall in the Craft, Mystery and Occupation of *a Farmer* which he the said  
*Levi Reedy* now useth, after the best manner that he can, or may teach, instruct, and inform,  
or cause to be taught, instructed and informed, as much as thereunto belongeth, or in any wise appertaineth, and that the said  
*Levi Reedy* shall also find and allow unto the said Apprentice sufficient meat, drink, apparel,  
washing, lodging, and all other things needful or meet, for an Apprentice during the term aforesaid: And also that the said  
*Levi Reedy* shall teach, or cause to be taught to the said *Reubin Moore*  
Reading, Writing and Common Arithmetic including the Rule of Three, and will moreover pay to the said *Reubin*  
*Moore* the Sum of *Twenty* Dollars at the Expiration of the aforesaid Term.
