bearing date the day of *June* in the year *1826*  
has placed and bound and by these presents doth place and bind *Washington Vance* ~~fifteen~~ *of the age* ~~Years~~  
of age *the 20<sup>th</sup> day of Novem. last*, to be an Apprentice with him the said *Horn*  
and as an Apprentice with him the said *Horn* to dwell from the date of these presents,  
until the said *Washington Vance* shall arrive and come to the age of *Twenty one*  
years, according to the Act of the General Assembly in that case made and provided, by and during all which time and term the said  
*Washington Vance* shall the said *Horn* his said

which he the said *Horn* now useth, after the best manner that he can or may teach,  
instruct and inform or cause to be taught, instructed and informed, as much as thereunto belongeth or in any wise appertaineth, and that  
he the said *Horn* shall also find and allow unto the said Apprentice sufficient  
meat, drink, apparell, washing, lodging, and all other things needful or meet for an Apprentice during the term aforesaid: And also that  
the said *Horn* shall teach or cause to be taught to the said *Washington Vance*  
Reading, Writing, and Common Arithmetic including the Single Rule of Three, and will moreover pay to the said *Washington*  
*Vance* the Sum of *Twenty* Dollars at the Expiration of the  
aforesaid Term. IN WITNESS whereof the Parties to these Presents have interchangably set their Hands and Seals the Day and Year  
above written.
