7th day of August 1818 William Alexander labourer
Joseph Graham Merchant & George W. Kemper
came before me, one of the commonwealths justice of the
peace for the Co aforesaid & acknowledge themselves
to owe James T. Huston esquire governor or chief
justice of the commonwealth of Virginia & his suc-
cessors, to wit, the said William Alexander in the sum
of one hundred ^{Dollars} & the said Joseph Graham one hun-
dred Dollars & George W. Kemper in one hundred Dol-
lars current money of Virginia to be respectively levied
& made of their several good chattels lands & tenements
to the use of the commonwealth aforesaid, if by the
said William Alexander, shall fail in performing
the conditions underwritten.

The conditions of the above obligation is such if the above
bound William Alexander shall personally appear at the
next court to be holden in & for the Co aforesaid, to do &
receive what shall then & there be enjoined him by the
said Court, & in the mean time to keep the peace
& be of good behaviour towards the commonwealth
& all its citizens, & Especially towards Charles P. F.
Charra in the 3^d Co lawfully keeping; then the 3^d obligation
to be void or else remain in full force.
