

Rockingham County to wit

Memorandum that upon this 26th day of January 1878
Martin Munger and Michael Deek of the County afo^r
came before the Jacob Bear a justice of the peace
for the County afo^r and each of them of his proper
persons acknowledged himself indebted to James Preston
Esquire Governor or Chief Magistrate of this Common-
wealth of Virginia and his successors in the sum of
one hundred and fifty dollars to be levied severalty of
each of their goods and chattels lands and tenements
respectively to the use of the said Commonwealth upon
Condition that each of them do personally appear be-
fore the Commonwealths justices of the peace for
the said County of Rockingham on the second day
of February at a Court by them to be held at the Court
house of the said County for the examination of Jas.
Conwell and James Fugett of the County afo^r and
do then and there on behalf of the said Commonwealth
give such evidence as he knoweth against the s^d Jas. Con-
well and James Fugett concerning the matters wherewith
they are charged and that neither he nor either of them do
depart without leave of the said Court then this recognizance
to be void else to remain in full force given under
our hands and seals this 26 day of Jan^y 1878

February next and then and there to hold a Court
for the examination of the fact with ~~which~~ which the
said James Cornwall and James Pugett stand char-
ged and for such other purposes concerning the prem-
ises as is by law required and directed and that you have
then and there this warrant. Given under my hand

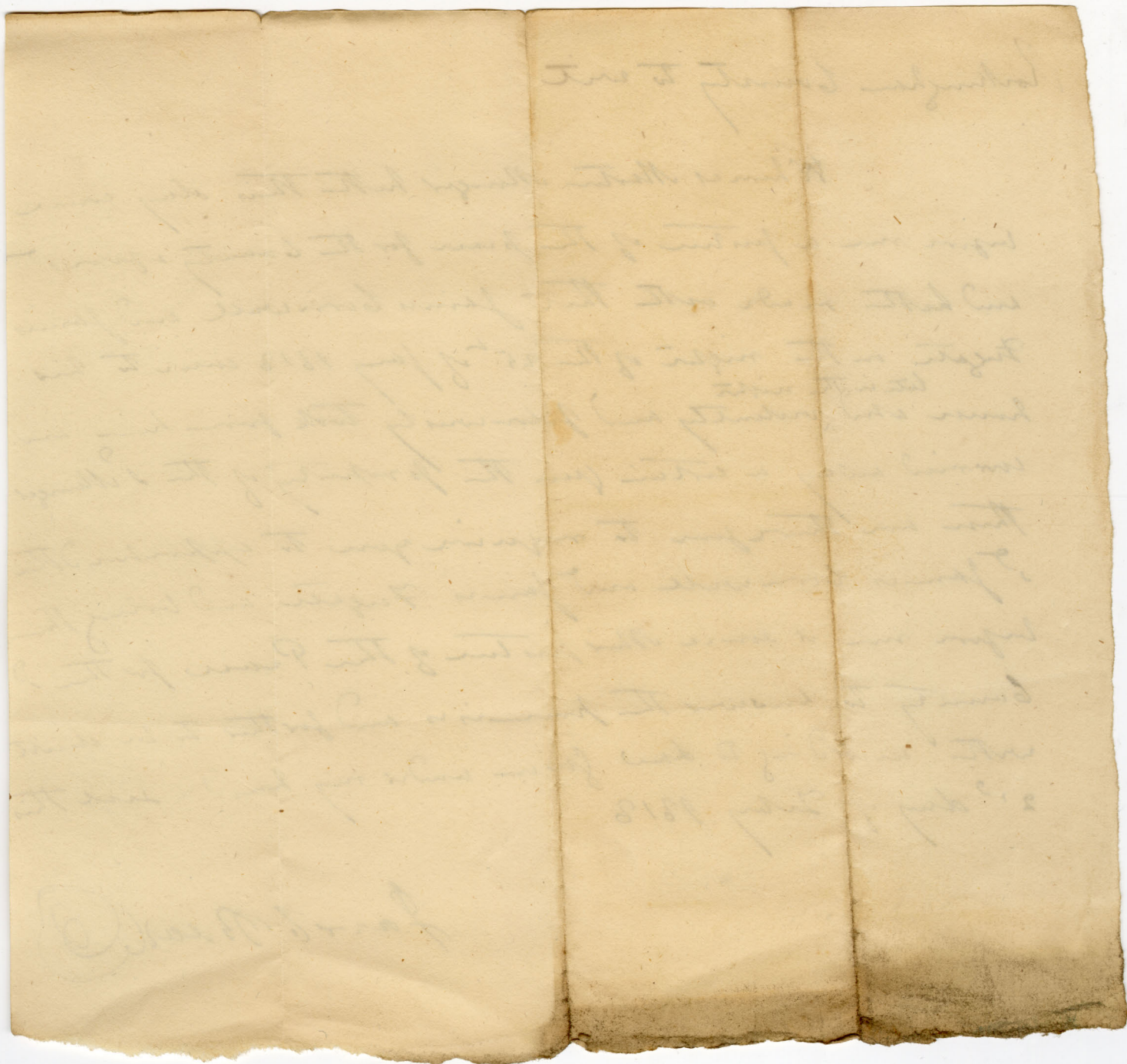

Whereas Martin Manges hath this day come
before me a justice of the Peace for the County aforesaid
and hath made oath that James Cornwall and James
Fugate on the night of the 25th of July 1818 came to his
house ^{late in the night} and feloniously took from him and
carried away a certain sum the property of the said Manges
there are those gone to require you to apprehend the
said James Cornwall and James Fugate and bring them
before me at some time justice of the Peace for the
County to know the premises and further to be dealt
with according to law given under my hand & seal this
2nd day of July 1818

Whereas James Cornwall and James Fugate late of the
County of Rockingham laborers have been arrested for suspicion
of Felony by them as it is said committed in Robbing a certain
Martin Mungel of a gun of the value of ~~8~~ seven dollars
the property of the ^{sd} Martin Mungel Therefore on behalf
of the ^{sd} Commonwealth I command you that you receive
the said James Cornwall and James Fugate into your cus-
tody in the ^{sd} Jail there to remain till he be delivered
from your custody by due course of Law given under my
hand & seal at the County aforesd the 2^d day of ~~July~~
