by my warrant, for unlawfully, maliciously,
& feloniously, wounding, disabling, maiming
and disfiguring, James Boswell a free man of
color, (Barber) with an intention, in committing
said, to kill, wound, disable, maim, ^{and} disfigure,
the said James Boswell, & it appearing to me that
the felonious offence, wherewith he stands charged
ought to be examined into by the County Court
Therefore on behalf of the Commonwealth
I require you, that you summon at least
eight of the Justices of your said County to
meet at the Court House on the 25th day
of March, 1825, & there & there to hold a Court
for the examination of the fact, with which the
said James Givens stands charged, and for such
other purposes, concerning the premises, as is by
law required, and directed, and that you
have then, there, this Warrant, Given under
my hand & Seal this 16th day of March 1825
