

Order of the County to wit

The Jurors for the body of the

County appear on this with presents this hitherto to wit
on the 1st day of May in the year 1831: and within the jurisdiction
of this Court Anthony Roads Surveyor of the Public
Road which leads from Bridgman's Point's Plantation to the
Point on the land of Samuel Gwinne for being part of the public
road commonly called the Woodstock back road, did not keep the
said Road from Bridgman's Point's Plantation to the said Point in
good and repair to wit that he the said Anthony Roads as Surveyor
did not keep the said mentioned road thirty feet wide and
well & smooth but permitted the said Road to be out of repair
as appears to wit on the day and year past against the Statute in
such case made and provided and against the peace and
dignity of the Commonwealth.

This Indictment
is found on the evidence of
Abraham Shear one of the Jurors
in the presence of the Grand Jury
