joins, and thereupon the Matter of Law arising on the said demurrer
being argued it seems to the Court that the said Declaration and the matters
therein contained are sufficient in Law for the Pleff to have and maintain his action
agt the said Defendant, therefore it is considered by the Court that the said
Demurrer be overruled.
