
Golden & Recogn Smith. 8. Jely 1840.



Be it remembered that on this 8th day of July 1840. Jacob Cockin hour alian Goodinous was before me Daniel Smith a Judge of the General Court and Judge of the circuit Superior court of Law & chancery of Bockingham county at the office of John Kenny rigi in the town of Harrisonburg & county of Bockingham, by virtue of the annewed wit of Hales Corpies and outjeindum herete fore i pued by the said Daniel Smith with the Jailon, saturn Thereon - and the said Daniel Smith being of Opinion and deciding That the said faced Cochinhour alia, Gockinow ought under all the Circumstances of the case to be admitted to bail himself in twenty five hundred dollars and two occurities in twelve hundred and fifty dollars each for his personal apprearance on the first day of the next term of the circuit superior court of law & chancery for The said county of Rockeryham to trial whom the Indictment refered to in the return of the failor - -And be it further rembered that therewhom the said faced Cockinhown alian Gochinoin and braham Lincolm and John R Homan yesman Came before the said Daniel Smith one of the Judges of the general Court as aforesaid and swendly acknowledged Thouseles to be indebted to theomas W.
