Year - 1858 in the said County - one red star of  
the value of fifteen dollars of the goods and chattels  
of Geo W Yancey then and there lying found unlawfully  
did steal take and carry away Against the Peace and  
dignity of the Commonwealth of Virginia

And the jurors aforesaid on this oath  
aforesaid do further - presents that the said Daniel  
Gette on the day and year - aforesaid in the  
County aforesaid - did unlawfully attempt - by false pretence  
to obtain from George W Yancey <sup>and David H Look</sup> the sum of fifteen dollars -  
with intent to defraud him the said George W Yancey  
by then & there - pretending falsely to him the said George  
W Yancey that he the said Daniel Gette was the legal  
owner of a certain red star of the value of fifteen  
dollars - and offering to sell ~~to him~~ and selling to the  
said George W Yancey the said star - the said Daniel  
Gette not being then and there the owner of the  
said star and the said star - being then & there  
the property of the said George W Yancey - but failed  
and was prevented from obtaining the said money with the  
intent aforesaid by the false pretence aforesaid.

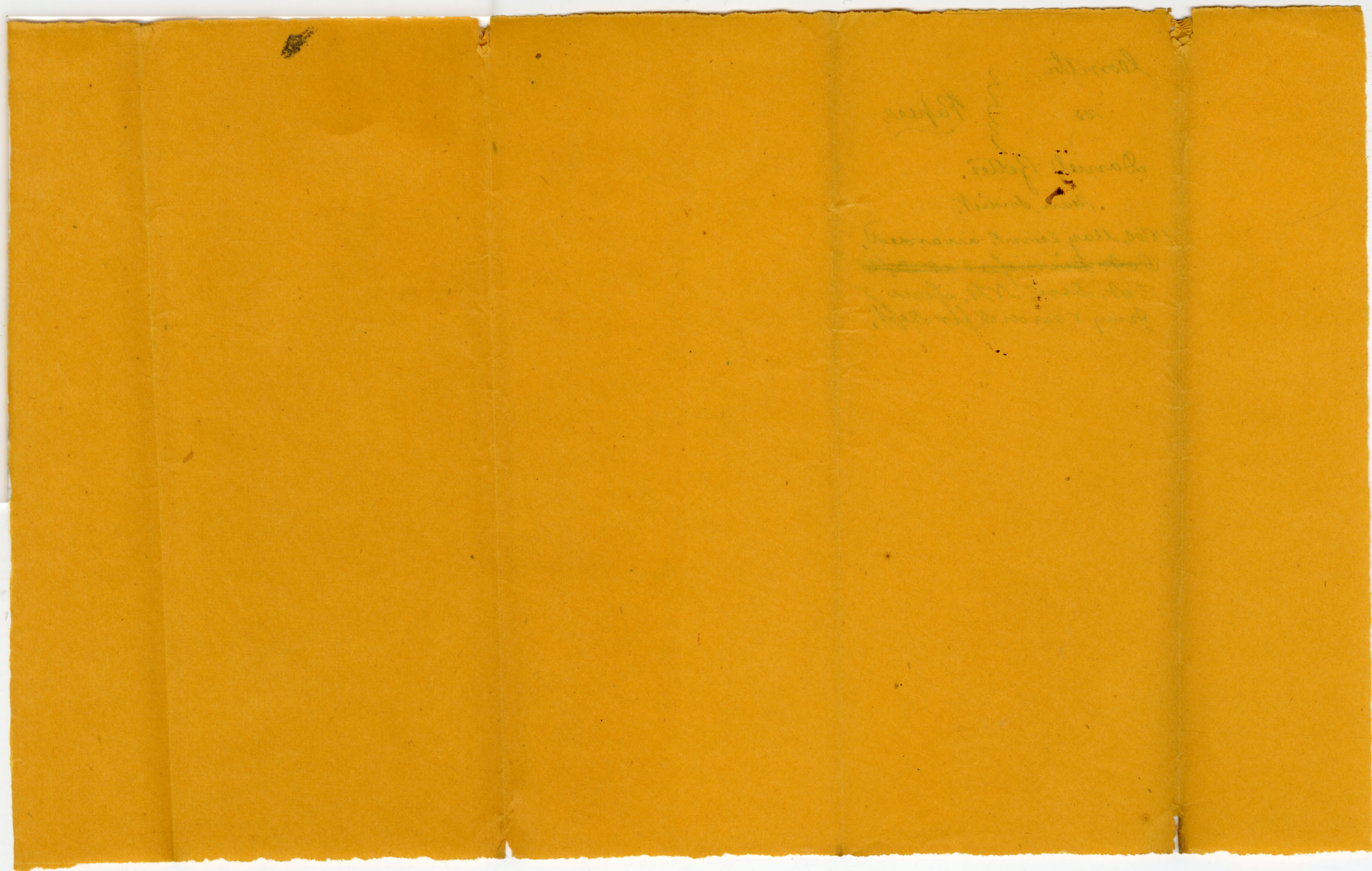
