have this day committed Hannah Eddings to the jail
of the County of Rockingham Va, that she may be indicted
in the court of Hustings of the said Town of Harrisonburg for a
misdemeanor by her committed in this, that she did on
the 24th day of June 1869, and at other dates previous to this
date in said Town, unlawfully being guilty of open and gross
~~immorality~~ lewdness, resorted to for the purpose of prostitu-
-tion with one James Javens in an open field within this
Town, and with different persons within the said town unknown
to J. P. Heydt Seargant of said Town, upon whose oath she has
been committed, and being of the opinion upon examination
of the said Hannah Eddings touching the said offence that
she ought to be tried therefor in the Hustings Court of said Town, require
bail of her in the amount of Two Hundred Dollars for her personal
appearance to answer an indictment for the said offence on the first
day of the next July Term of the said court and she having failed
to find such bail
