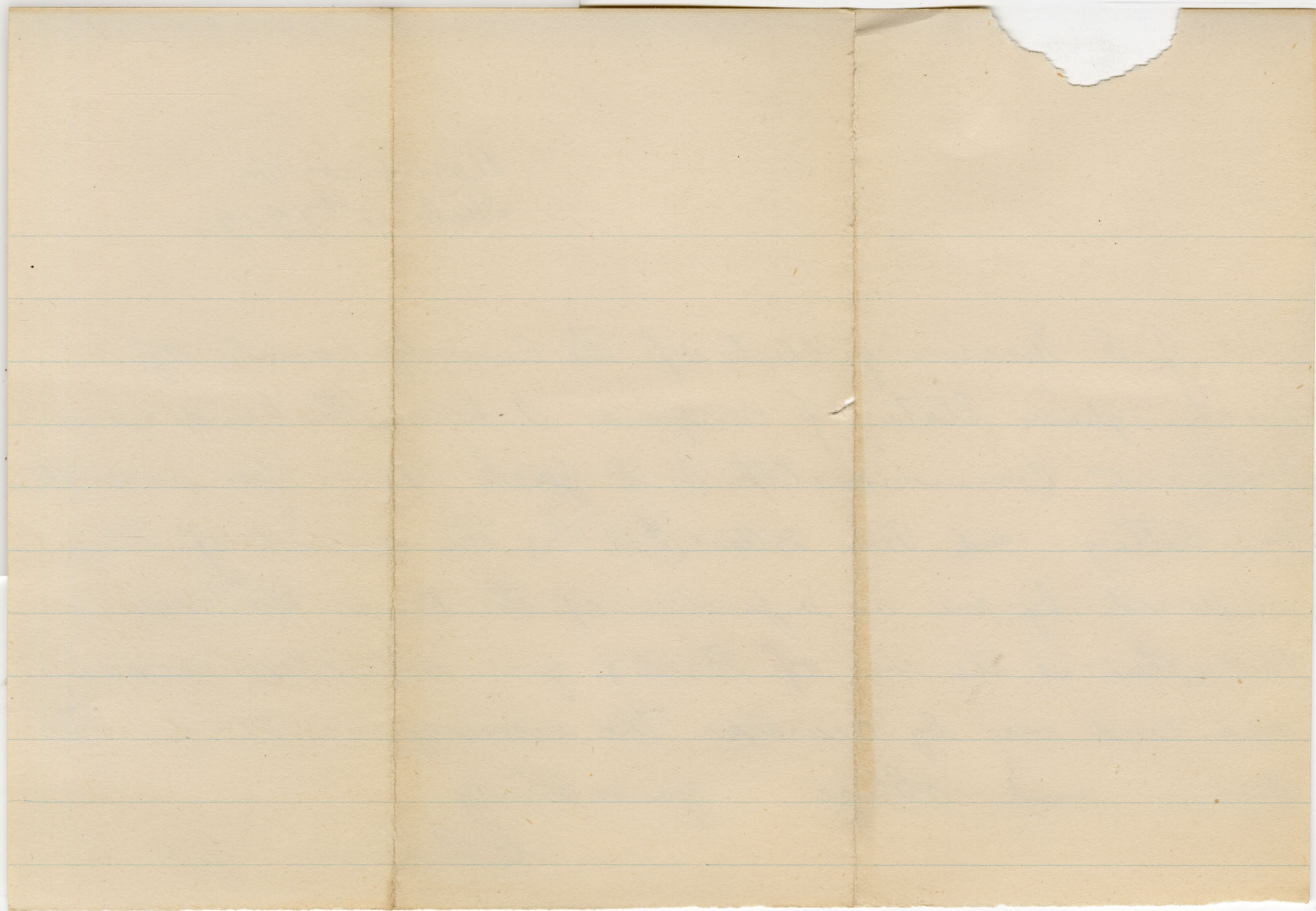

To H T Workman *Special Police*, a Constable of said County:

WHEREAS, Ida J. Cash of the said county, has this day made complaint and information on oath before me, C. B. Lam a Justice of the said county, that

Jack = Cash  
of the said county, on the 25<sup>th</sup> day of January 1902, in the said county, did  
unlawfully assault and Beat the said Ida J. Cash by striking  
her with his closed fist and threaten to kill her the said  
Ida J. Cash and her children they being the said Jack Cash  
own Family and said Ida J. Cash does require Surety for  
the said Jack Cash for to keep the peace for her and  
her children protection

These are therefore, in the name of the Commonwealth of Virginia, to command you forthwith to apprehend and bring before me, or some other Justice of the said County, the body of the said

Jack Cash  
to answer the said complaint, and to be farther dealt with according to law. And you are required to summon  
Ida J. Cash, Minnie Cash, Edward Watters, Ashbey Lam,  
Hurdle Rodgers

to appear and give evidence in behalf of the Commonwealth, on the examination touching the said offence.
