THE CONDITION OF THE ABOVE OBLIGATION IS SUCH, That, *Whereas the above bound Syron Hoover was on this 22nd day of September 1891 committed to the jail of the County of Rockingham by J. M. Rector, a Justice of the Peace of said County to await the action of the Grand Jury of a felony whereof he stand charged. Now if the said Isaac Hoover shall make his personal appearance before the Judge of the County Court of the County aforesaid to await the action of the Grand Jury aforesaid, on the 1st day of the November Term next of said Court being November 16, 1891, and not depart thence without leave of the Court.* shall faithfully discharge the duties of *said Office and Trust, according to law; then this*

Obligation to be void, or else to remain in full force. And the obligors herein do hereby severally waive, in respect to their obligations and liabilities in virtue of this bond, all benefit of exemption whatsoever, under and by virtue of the Act of General Assembly of Virginia, Chap. 157, of the Session Acts 1869 and '70, approved June 27th, 1870, and commonly known as the Homestead Exemption Act. And do also hereby waive any claim, right or privilege to discharge any liability arising under said bond, or by virtue of said office or trust, in any currency, funds, counter-claims or offsets other than legal tender currency of the United States.
