one silver dollar, <sup>amount of this Commonwealth</sup> and of the value of \$1.00, three bonds for the payment of  
\$169.00, \$146.00 & \$140.00 respectively and of the value of \$169.00, \$146.00 & \$140.00  
respectively, & one note for the payment of \$440.00 and of the value of \$440.00

all of the said personal property then being the property of said S. N. Kariocofe, and the  
said sums of \$169.00, \$146.00 and \$140.00 respectively, payable and secured by and upon  
said bonds being then due & unsatisfied to the said S. N. Kariocofe, and the said

N. Sandy* in said dwelling house then being, feloniously did steal, take + carry away
