

COMMITMENT TO ANSWER INDICTMENT.

VIRGINIA, COUNTY OF ROCKINGHAM---TO-WIT :

To *The Chief of Police of Harrisonburg* of said County, and to the Keeper of the Jail thereof:

These are, in the name of the Commonwealth of Virginia, to command you, the said *Chief*, forthwith to convey and deliver into the custody of the keeper of said jail, together with this warrant, the body of.....

Moses Banks..... charged before me, *Wm. J. Poind*..... a justice of

the peace of said county, on oath of *Lawrence Davis & Ella Miller* with a felony

by him committed, in this, that he, the said *Moses Banks*, on the

25th day of *November*, 190*8*, in said county, *did unlawfully*

maliciously and feloniously make and assault and Battery upon Lawrence Davis and Ella Miller, with stones upon the public highway, with intent for main disfigure or kill them - and being found probably guilty was sent to the Circuit Court of said County in further trial

.....and you, the keeper of the said jail, are hereby required to receive the said

Moses Banks.....into your jail and custody, that he may be tried for the said offence before the ~~court~~ court of said county, and him there safely keep, until he shall be discharged
