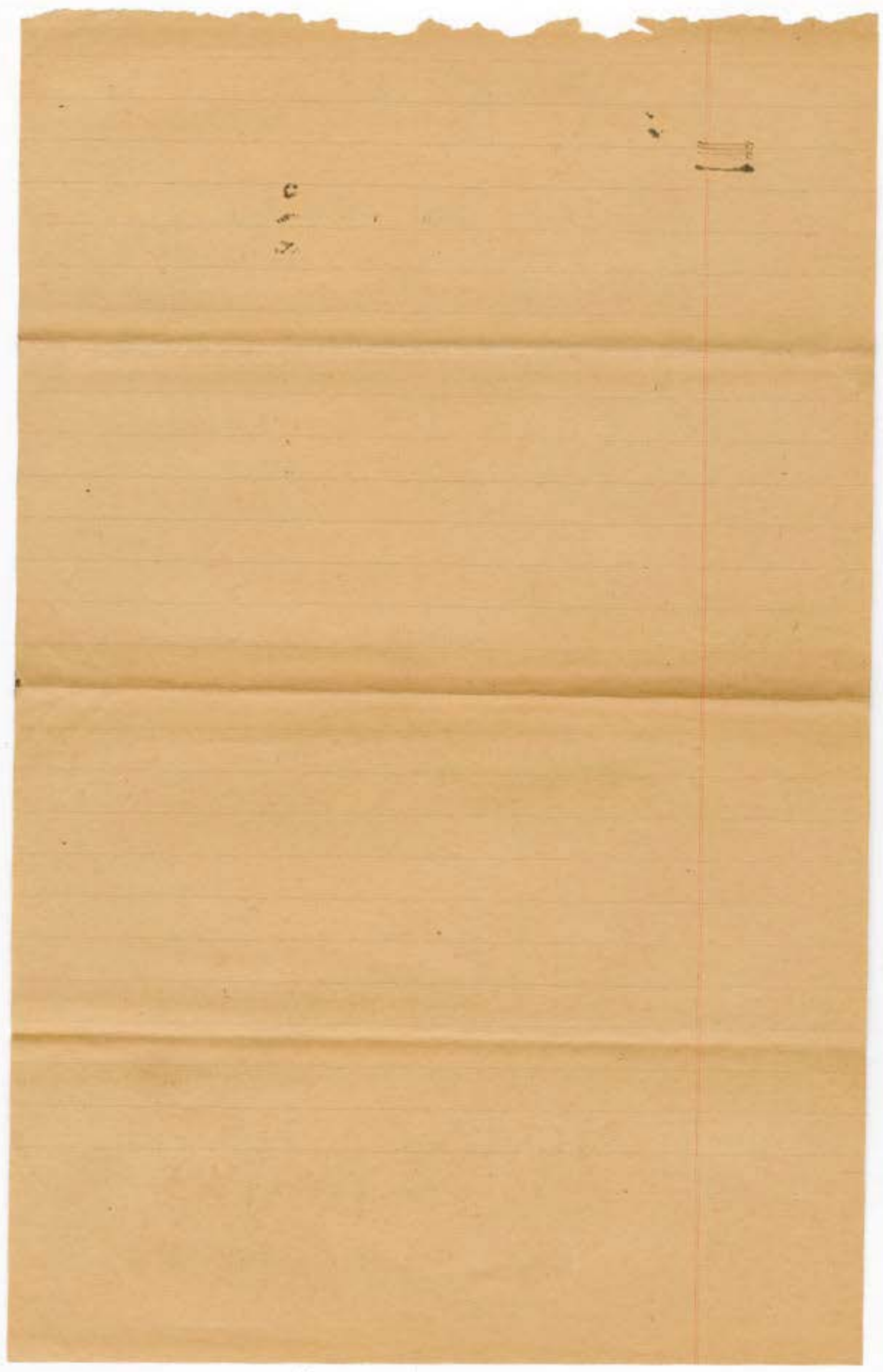

Instruction No.

The Court instructs the jury that it is incumbent upon the Commonwealth to prove beyond a reasonable doubt that the accused committed the ~~same~~ crime with which he is charged in the warrant within the town of Harrisonburg, that is, within the corporate limits of the said town of Harrisonburg, ~~or~~ *or within beyond said corporate* ~~limits~~ *limits;* and if the jury believe that the accused committed the crime with which he is charged in the warrant but further believe that the accused did not commit the said crime within the corporate limits of the town of Harrisonburg, or, ~~from the evidence~~ *are not convinced* ~~xxxxxxx~~ beyond a reasonable doubt where the accused committed the said crime charge in the warrant, then the jury must find the accused not guilty.
