Homer Moubray and I had come in on the bus from Elkton, reaching Harrisonburg a little after 3:00 P. M. Homer and I had been to the Harrison Hotel, and were coming back up the street, when we met Betty Morrison and Owen McDaniel in front of the Bus Terminal.

When we met them, we stopped and were talking to Owen. We stood there for a pretty good while talking to them. About an hour or more, I imagine. Then **EtayArMarrism**x Floyd Morris came along, and we (Homer and I) walked across the street to a restaurant and got a drink of beer. We had one bottle each.




