There was this 7th day of April, 1930, presented to the Judge of this court, in vacation, the petition of the State Commission on Conservation and Development, with exhibits thereto attached, and verified by affidavit as required by law, praying leave to file said petition, with exhibits, and praying further that the court shall make and direct an Order of Notice as prescribed in Sections 9 and 20, Chapter 410 of the Acts of the General Assembly of Virginia of 1928 (Public Park Condemnation Act, page 1036 of the Acts of 1928), fixing a day certain on or before which any and all persons owning or claiming any right, title, estate or interest in or to the land within the area set forth and described in said petition, or in or to the proceeds arising upon the condemnation of said lands, or to damage or damages as contemplated and provided for under Section 20 of said Act, shall appear, and by appropriate pleading assert their several or respective demands or claims, and praying further that the Court may, by its order designate some newspaper for the publication of said notice, and that rules may be made fixing dates for the appearance and the filing of pleadings by parties owning or claiming any right, title, estate or interest in or to said lands, or in or to the proceeds arising upon a condemnation thereof, or to said damage or damages and the same was thereupon argued by counsel.

Upon consideration whereof, the Court doth order that the <sup>7th</sup> day of June, 1930, be and the same is hereby fixed as the day on or before which any and all such persons so owning or claiming

any right, title, estate or interest in or to said lands above mentioned, or in or to the proceeds arising upon a condemnation of said lands, or to damage, or damages as contemplated and provided for under Section 20 of said Act shall appear, and by appropriate pleading, assert their several or respective demands or claims;

And the Blue Ridge Guide, a newspaper published and circulated in Rappahannock County, Virginia, is hereby designated as the newspaper in which said notice shall be published;

The Clerk of the Circuit Court of Rappahannock County, Virginia, is hereby directed to prepare and deliver to said newspaper the above mentioned notice for publication by said newspaper, and said newspaper shall publish the same once a week for four (4) successive weeks;

Said notice and the proceedings had in connection therewith shall be in conformity with and substantially as the form set forth in Sections 9 and 20 of said Public Park Condemnation Act, and shall contain the names of persons and classes of persons owning or claiming or possibly owning or claiming some right, title, estate or interest in or to the land or any part thereof, or to the proceeds arising from the condemnation thereof, or to damage or damages as contemplated and provided for by Section 20 of said Act, together with the respective residences and addresses of said persons and classes of persons and whether they are residents or non-residents of the State of Virginia;

Said Clerk shall, as early as practicable and not exceeding five days after the day of entry of this order, make and deliver to the Sheriff of Rappahannock County, Va., a sufficient number of copies of said notice for the purpose of posting, and return as hereinafter ordered;

And said Sheriff shall, as early as practicable, and not exceeding five days after the receipt of such copies, post or cause to be posted one copy of the same at the front door of the Court House of Rappahannock County, Virginia, and shall make due return of such posting upon one of said copies.

And, said Clerk shall, as early as practicable and not exceeding twenty days after the first publication of said notice, mail to each person whose name and address is stated in the petition, a copy of said newspaper containing the notice, and shall make and file as a part of the record of the case a certificate showing the mailing of such copies.

And The Clerk of The Circuit Court of Rappahannock County is directed to record this Order in the proper Common Law Order Book of his office.
