

THIS INDENTURE

MADE THE *fourth* day of *January*
in the year of our Lord 18 *21* Between *Aaron Solomon* Overseer of the Poor of the
South East District in the County of Rockingham of the one part and *Philip Royer*
of the other part, witnesseth, that the said Overseer of the Poor aforesaid by virtue of an Order of the Court of the County aforesaid
bearing date the *December* day of *1820* in the year
has placed and bound and by these presents doth place and bind *Barbara Summers* of the age
of *five and a half* years, to be an Apprentice with him the said *Philip Royer*
and as an Apprentice with him the said *Philip Royer* to dwell ~~from the date of these presents,~~
until the said *Barbara Summers* shall arrive and come to the age of *eighteen*
years, according to the Act of the General Assembly in that case made and provided, by and during all which time and term the said
Barbara Summers shall the said *Philip Royer* her ~~his~~ said
Master well and faithfully serve in all such lawful Business as the said *Barbara Summers*
shall be put unto by *Philip Royer* according to the Power, Wit and Ability of *the said Barbara Summers*
and the said *Barbara Summers* shall honestly and obediently in all things behave towards
her said *Master* and honestly and orderly towards the rest of the Family
of the said *Philip Royer* And the said *Philip Royer*
for himself *his* Executors and Administrators doth hereby promise and covenant to and with the said Overseer of the Poor and his
Successor for the time being, that the said Apprentice shall in the Craft, Mystery and Occupation of *Spinning Knitting*
~~which he the said~~ *Sewing Cooking &c* ~~now useth,~~ after the best manner that he can or may teach,
instruct and inform or cause to be taught, instructed and informed, as much as thereunto belongeth or in any wise appertaineth, and that
he the said *Philip Royer* shall also find and allow unto the said Apprentice sufficient
meat, drink, apparell, washing, lodging, and all other things needful or meet for an Apprentice during the term aforesaid: And also that
the said *Philip Royer* shall teach or cause to be taught to the said *Barbara Summers*
Reading, Writing, ~~and Common Arithmetic including the Simple Rule of Three,~~ and will moreover pay to the said *Barbara*
Summers the Sum of *fifteen* Dollars at the Expiration of the
aforesaid Term. IN WITNESS whereof the Parties to these Presents have interchangeably set their Hands and Seals the Day and Year
above written.
