The Student-Faculty Committee met Tuesday, March 10, at 4:00 p.m. in the Bookstore Lobby. Dr. Morrison was unable to attend so Miss Spresser chaired the meeting.

Bev Trainham referred us back to the status changes and said it was necessary to keep the phrase, "and becomming 22, which allows the student to have a car on campus." The Deans recommended this.

A lengthy discussion followed on the Alcoholic Beverages Regulations. Number one in this section is the same as the section found on page 53 of the Handbook, however, items 2-6 are additions. The committee discussed each item separately. Since the working of several of the rules was not clear, the committee decided to re-phrase them and combine several of the ideas. The revisions and changes, as made by this committee, are as follows:

1. no change

- 2. The consumption of alcoholic beverages in motor vehicles will be governed by State law.
- 3. Consumption of alcoholic beverages shall be permitted only in students private rooms, duly licensed areas under State law for sale of alcohol, or at functions where its use is approved by the Dean of Student Services.
- 4. Sale of alcoholic beverages on campus will be permitted only under provisions of State law.
 - 5. the same
 - 6. the same

Mr. Griffin moved to accept this revision as a whole. The motion was seconded and passed by a unanimous vote.

The next discussion was on the section, "Men in Women's Dorms." Dr. McFarland pointed out that the phrasing of the revision should be improved. The committee changed the wording. The committee's revison reads as follows:

"Men are permitted in the public reception area of the women's dormitories unless specific permission is granted by the head resident or special permission is given by the Dean of Women or Dean of Men for open houses. Women are permitted in the public reception area of the men's dormitories unless permission, as stated above, is granted."

Mike Cappeto, who helped organize the open houses this year, said he felt careful consideration should be given to them. After discussion, the committee made the following additions to the above revision:

"Exceptions to the above may be approved by the Head Resident, Dean of Women, or Dean of Men. Open houses are granted specifically by the Deans mentioned."

Bev Trainum moved we accept these revisions. The motion was seconded by Mike Cappeto and carried with nine members for it and one against.

Bev Trainum then moved that a subcommittee of Rules Review be formed to draw up regulations for Open Houses, subject to the approval of the Dean of Men and Dean of Women. Dean Bowers and Dean Reubush joined the meeting at this time. After a discussion with them on Open Houses, Bev withdraw her motion.

Lisa Crider moved that policies governing such Open Houses shall be formulated and enforced by Student Government. The motion was seconded and carried.

Lisa then moved the committee delete the sentence concerning visiting hours in the section. The motion was seconded and carried.

The meeting closed at approximately 5:15 p.m. The next meeting will be held on April 2, 1970 at 4:00 p.m. in the President's Conference Noom.
